The Department of Revenue and Taxation Releases its FAQ for Online System for Guam Tax Payments

Barrigada, Guam – The Guam Department of Revenue and Taxation (DRT) releases its list of frequently asked questions (FAQs) regarding the types of payments that can be made utilizing its official online system PayGuam. In order to help protect the health of taxpayers and tax professionals during the COVID-19 pandemic by reducing the risk of in-person exposure, DRT highly recommends making tax payments online to the extent available.

Payments with outstanding bills, such as Gross Receipts Tax (GRT) and Income Tax Receivables, must have a personal identification number (PIN) code after registering online. The PIN code is to ensure all data retrieved and displayed are secured and protected against identity theft and fraud.

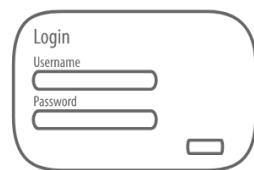
All other payments (i.e. Real Property Tax, Insurance Assessment Fees, Estimated Individual Income Tax (1040ES), Corporation Estimated Taxes, etc.) can be made immediately after registering and do **not** require a PIN code.
