# **Special Services Guide** for Insurance Companies & Their Agents



## **Online Vehicle Insurance System**

As part of our continuing efforts to enhance services to the taxpayers of Guam, the Department of Revenue and Taxation has launched the Online Vehicle Registration Renewal Service, which allows vehicle owners to renew their vehicle registrations electronically using MyGuamTax.com.

## **Role of Insurance Companies & Their Agents**

Renewal of a vehicle registration online is contingent upon the online submission of required registration data from special third parties, as follows:

- A "Passed" Vehicle Safety Inspection from an authorized safety inspection station
- A current insurance policy from an authorized insurance company

#### At a Glance...

#### WHAT:

Online Vehicle Registration Renewal Service

#### **DESCRIPTION:**

Allows vehicle owners to renew their vehicle registrations electronically over the Internet.

#### **SUPPORTING SERVICE:**

The Online Vehicle Insurance System allows insurance companies and their agents to submit required vehicle insurance policy data to Rev&Tax electronically over the Internet using GuamTax.com.

This system works in conjunction with the Online Vehicle Registration Renewal Service.

**YOUR ROLE:** 

To facilitate the online renewals of vehicle registrations by submitting insurance policy data to our department via the online system for commercial entities, GuamTax.com

### **Methods for Online Data Submission**

Insurance companies and their agents have two methods of submitting data online:

#### **INDIVIDUAL**

This method allows you to add or update required policy information one record at a time.

#### **BATCH**

This method allows you to specify a batch file to upload to our system to massively add or update insurance policy records.

## **Technical Requirements**

To utilize the batch upload method, the batch file must be fixed-length, ASCII text file in the format described below: (Records/lines are separated by CR/LF).

## Register for a GuamTax account

Your company must register for an account using the Registration Form for Specialized Services Providers, which can be downloaded from the GuamTax.com site. Insurance companies may register for more than one GuamTax account.

Each user account will be able to access and update data entered by other user accounts from the same insurance company. Insurance agents may also register for multiple accounts, but access to data will be limited to the respective user's account only, unless granted companywide access by its represented insurance company.

## **GuamTax.com System Requirements**

To use the online services available on GuamTax.com, you must have the following:

- Internet access
- Standard web browser with Cookies and Java enabled \*GuamTax.com optimized for Microsoft Internet Explorer
- Latest version of Adobe Reader, available for free from adobe.com.
